# **Superintendent's Report:**

- GREAT NEWS! 4 years ago MCSD was designated as Lowest Performing according to the state. I have received a letter with our new designation of Commendable for the Jr. High and the elementary. We have moved up two levels in two years. This is the best news I have received for our educational process. We are moving in the proper direction.
- We did not receive the kitchen grant. The letter we received said the funding had run out. Thanks to Mrs. Browning and Mrs. Gregory for trying.
- There will be no Truth in Taxation hearing this year. We have not raised taxes over the 5% increase which allows us not to do this process. They have actually decreased by 2.5%.
- We will be starting Public School Works after the first of the year. This is a program that will allow our staff do all of the mandated reporting that is required through the state.
