Henson Robinson came and repaired but it's not under warranty. The architect is supposed to be coming out to check it. I have video of the sewer line if anyone wishes to view it.
- We received our \$300,000 working cash bond money March 6th which is good timing with the issues we are having.
- Mr. Carie will be retiring at the end of this year. I would like to post the position following the board meeting. We have received several applications.
- I have had some sewer and plumbing issues at my house this week so I have been showering at the school and hopefully it will be resolved today.
